You will be required to produce **adequate photographic personal identification** in the form of a Passport, a Channel Island/UK Driving Licence (bearing a computerised photograph), a UK Citizen Card or an EU National Identity Card.

NOTE – A Basic Disclosure does not list your **spent** convictions and / or cautions and as such is not suitable for visa / immigration purposes or other purposes. If you require a complete list of your convictions and / or cautions (or a document stating such a check has been conducted) please ask for advice.
